

ESTRO 2025 Registration Policy

The registration and participation in **ESTRO 2025** are governed by this Registration Policy. By submitting your registration for **ESTRO 2025**, you are deemed to have agreed to comply with this **ESTRO 2025** Registration Policy.

Interpretation

ESTRO 2025 refers to the annual meeting and pre-meeting courses organized by or on behalf of ESTRO (European Society for Radiotherapy and Oncology) held from May 3rd to May 7th, 2025.

Registration Eligibility

ESTRO 2025 is open to healthcare professionals with an interest in radiotherapy and oncology, as well as representatives from exhibiting companies and individuals invited or approved by ESTRO. The individuals participating in ESTRO 2025 are hereinafter referred to as "delegates" or "corporate representatives".

Procedure

ESTRO no longer accepts registration orders for Health Care Professionals directly from pharmaceutical and Medical Technologies companies. This policy adjustment is in accordance with the implementation of our EACCME® accreditation, as outlined in its regulations. We invite delegates to take charge of their registration by independently accessing our ESTRO 2025 registration website.

Registrations can be made in advance online through the official ESTRO 2025 registration website or onsite at the dedicated registration desks. Generally, registrations are processed on a first-come, first-served basis. ESTRO will promptly notify individuals whose registrations could not be accepted. However, confirmation of registration is subject to full payment.

Username and password

To register for ESTRO 2025 via the website, it is necessary to create a **MyESTRO** account, enabling you to set your own privacy preferences in accordance with the [ESTRO Privacy Statement](#).

It is your responsibility to maintain the confidentiality of your password and account, as well as to report any suspected unauthorized use of your account or any security breaches to ESTRO. ESTRO will not be held liable for any loss incurred due to the unauthorized use of your account.

Registration Fees

The registration fees for ESTRO 2025 are outlined on the official ESTRO 2025 registration website, www.estro.org. The registration fee for full congress delegates includes conference participation, access to the industry exhibition, and access to the digital platforms. Registration fees and other associated charges are inclusive of VAT.

ESTRO 2025 has different fees, conditions and deadlines. These fees are outlined on ESTRO 2025 registration website, www.estro.org/Congresses/ESTRO-2025.

These different types of fees are:

1. Full Registration Fee: This fee includes conference participation, access to the industry exhibition, and access to the digital platforms for the entire duration of the congress.
2. One-Day Full Registration: The fee for one-day full congress registration includes conference participation, access to the industry exhibition, and access to full scientific sessions on the digital platforms for a single day.
3. Pre-Meeting Courses Fee: The pre-meeting courses fee covers only the pre-meeting courses and grants access only to the pre-meeting session on the digital platforms. It does not provide access to the full congress or the industry exhibition.
4. Contouring Workshop Fee: The contouring workshop fee is an additional charge for attending only the contouring workshop sessions during the congress.
5. Visitor Fee: The visitor fee allows access only to the industry exhibition floor. It does not include access to the scientific sessions or the digital platforms.

The registration for "After-Dinner Event" registration is not included in any of the registration fees. All registration fees are quoted in Euros and include VAT, unless otherwise specified."

Indirect taxes/ Withholding taxes

To ensure compliance with withholding tax or indirect tax regulations, such as VAT, GST, or sales tax, the Customer is considered to be located at the place indicated in the "Company details" section as reported on the ESTRO 2025 registration form. Upon specific request, invoices can be sent to the address specified under "Invoice details." However, it is important to note that the billed entity remains the "Company details" entity.

All fees for "non-On-site" services such as, but not limited to on-line advertising, ESTRO 2025 tools are deemed to be provided at the place of the "Company details" and will be subject to the rules defined by the European VAT Directive EC/2006/112.

Fees and charges are net of any local taxes applicable in the country of the Customer, such as, but not limited to (when applicable) VAT, GST, Sales tax, withholding tax or any similar tax of any nature whatsoever. All present and future Customer's local taxes, as well as fines and/or penalties and/or interest assessed directly or indirectly on such amounts (if any) which may apply to fees or charges due for or in connection with the conference, will always (even retroactively) be borne by the Customer. The Customer is solely responsible for paying any such local taxes in addition to applicable ESTRO fees and charges. ESTRO cannot be held responsible for seeking any refund of such local taxes and will not initiate any procedure to that effect."

Payment Method

ESTRO accepts payment for ESTRO 2025 registration by credit card or electronic bank transfer. If you prefer to pay by electronic bank transfer, please contact the event team at events@estro.org. An invoice or pro forma with relevant payment instruction details will be sent to you via a link in your confirmation email.

Cancellation and Refund

ESTRO understands that circumstances may arise which require you to cancel your registration:

1. Refund: If you decide to cancel your registration, you will be eligible to receive a refund of 85% of the registration fees. The remaining 15% will be retained to cover handling charges.
2. A refund is solely issued to the original account from which the invoice payment was made.
3. Cancellation deadline: Please note that any cancellation request received within 1 month before the date of the congress will not be eligible for a refund.
4. Transfer of Registration: a registration cannot be transferred to another individual.

Insurance

ESTRO does not accept liability for individual medical, travel or personal insurance. In the event of unforeseen or serious circumstances beyond its control, ESTRO shall be entitled to cancel or modify the dates of the event. Delegates shall not be entitled to compensation for any costs or damages incurred as a consequence of such a cancellation or change. All delegates are urged to take personal travel insurance.

ESTRO will not be liable for any theft or damage to property and/or persons caused on site during the congress, by any factor whatsoever, unless there has been a fault, intent, or deliberate recklessness on the part of ESTRO. ESTRO shall not be held responsible in the event of poisoning or food intoxication during the event.

Event Rules and Regulations

Whilst participating in ESTRO 2025, you are required to comply with any policies or directions (such as but not limited to security, health, and safety regulations) in force at the time of the event, given by or for ESTRO or any other relevant third party, including the person responsible for the premises where ESTRO 2025 takes place or any competent authority. You must wear your badge at all times. Your badge is strictly personal and may not be transferred to another person or modified.

ESTRO accepts no responsibility for any belongings you may bring to ESTRO 2025. Bringing such belongings is at your own risk.

Children under the age of 18 are not permitted on scientific sessions and the Exhibit Hall floor.

Lead Retrieval Device

Exhibiting companies can order separately a Lead Retrieval Device that allows them to scan badges of ESTRO 2025 participants as to obtain reports on attendance.

This device is licensed to the Exhibiting companies for the purpose of scanning ESTRO 2025 participants' badge only on their stand location or at a location where the Company is organising a satellite Symposium, event, cocktails, dinner.

Scanning of your badge by an Exhibiting company should always be done with your express consent. By scanning your badge, the Exhibiting companies will collect your title, first name, family name, institution, specialty, address, country, and e-mail address.

This information should only be used by the Exhibiting companies for the purpose of evaluating attendance and to present their products and services directly to you by e-mail.

Attendees
