

ESTRO 2021 Registration Policy

Registration for and participation in **ESTRO 2021** are subject to this Registration Policy. By submitting your registration for **ESTRO 2021**, you will be considered to have agreed to this ESTRO 2021 Registration Policy.

Interpretation

ESTRO 2021 means the 2021 annual meeting organised by or for ESTRO (European Society for Radiotherapy and Oncology) from 31 August until 1 September 2021 in Madrid, at the IFEMA – Feria de Madrid Avda. del Partenón, 5 28042 Madrid.

Registration Eligibility

ESTRO 2021 is open to representatives from ESTRO Users (that is, ESTRO shareholders, Sub-members and other eligible ESTRO users), representatives from Exhibiting companies and other persons invited or approved by ESTRO.

The individuals participating to ESTRO 2021 are hereinafter referred to as 'participants' or 'delegates'.

Procedure

Registrations can be made in advance online via the official ESTRO 2021 registration website and onsite at the dedicated registration desks.

ESTRO acknowledges receipt of registrations. As a principle, registrations are processed on a first come, first served basis. Once capacity is reached, any further registrations are put on a waiting list. ESTRO will promptly notify the persons whose registrations could not be accepted. In any event, confirmation of registration is conditional upon full payment.

Username and password

In order to register to ESTRO 2021, you will need to create an account. This will allow you to determine your own privacy settings (in accordance with the ESTRO 2021 [Privacy Statement](#)).

In any case, you are entirely responsible for maintaining the confidentiality of your password and account, as well as for any and all activities that occur under your account.

In addition, you agree to notify ESTRO immediately of any (suspected) unauthorised use of your account or any other breach of security. ESTRO will not be liable for any loss that you may incur as a result of someone else using your password or account.

Registration Fees

ESTRO 2021 registration fees are as set out on the official ESTRO 2021 registration website www.estro.org.

The registration fee for a participant includes participation in the conference and access to the exhibition (live registration) and access to the digital platform (live registration + online registration).

Registration fees and any other related fees and charges are VAT included.

Indirect taxes/ Withholding taxes

For the correct application of withholding tax or indirect tax rules, similar but not limited to VAT, GST or Sales tax, the Customer is deemed to be located at the place of the "Company details" as reported on the ESTRO 2021 Registration form (i.e. "the Customer"). Upon specific request, the invoices can be sent to the place indicated under "Invoice details". The billed entity remains however the "Company details" entity.

All fees for "Non On-site" services such as, but not limited to on-line advertising, ESTRO 2021 Tools are deemed to be provided at the place of the "Company details" and will be subject to the rules defined by the European VAT Directive EC/2006/112.

Fees and charges are net of any local taxes applicable in the country of the Customer, such as, but not limited to (when applicable) VAT, GST, Sales tax, withholding tax or any similar tax of any nature whatsoever. All present and future Customer's local taxes, as well as fines and/or penalties and/or interest assessed directly or indirectly on such amounts (if any) which may apply to fees or charges due for or in connection with the Conference, will always (even retroactively) be borne by the Customer. The Customer is solely responsible for paying any such local taxes in addition to applicable ESTRO fees and charges. ESTRO cannot be held responsible for seeking any refund of such local taxes, and will not initiate any procedure to that effect."

Payment Method

ESTRO accepts payment for ESTRO 2021 registration by credit card or electronic transfer. If you prefer to pay by electronic transfer, please indicate your intention to do so by using the appropriate section on the official ESTRO 2021 registration website. A pro forma invoice with relevant payment instruction details will be sent to you via a link in your confirmation email.

Cancellation of Registration

You can cancel your registration and get a full refund of the registration fee minus handling charges of 15%. This option is available until 2 months before ESTRO 2021, i.e. until 27 June 2021. Between 27 June and 12 August 2021, the refund will amount to 50% of the registration fee. No refund will be possible if the cancellation is postmarked after 12 August 2021.

Insurance

ESTRO does not accept liability for individual medical, travel or personal insurance. In the event of unforeseen or serious circumstances beyond its control, ESTRO shall be entitled to cancel or modify the dates of the event. Delegates shall not be entitled to compensation for any costs or damages incurred as a consequence of such a cancellation or change. All delegates are urged to take personal travel insurance.

ESTRO will not be liable for any theft or damage to property and/or persons caused on site during the Congress, by any factor whatsoever, unless there has been a fault, intent or deliberate recklessness on the part of ESTRO. ESTRO shall not be held responsible in the event of poisoning or food intoxication during the event.

Event Rules and Regulations

Whilst participating in ESTRO 2021, you are required to comply with any policies or directions (such as but not limited to security, health, and safety regulations) in force at the time of the event, given by or for ESTRO or any other relevant third party, including the person responsible for the premises where ESTRO 2021 takes place or any competent authority. You must wear your badge at all times. Your badge is strictly personal and may not be transferred to another person or modified.

ESTRO accepts no responsibility for any belongings you may bring to ESTRO 2021. Bringing such belongings is at your own risk.

Lead Retrieval Device

Exhibiting companies can order separately a Lead Retrieval Device that allows them to scan badges of ESTRO 2021 participants as to obtain reports on attendance.

This device is licensed to the Exhibiting companies for the purpose of scanning ESTRO 2021 participants' badge only on their stand location or at a location where the Company is organising

event, cocktails, dinner. The Exhibiting companies are not authorised to use the device in any other area, such as in conference rooms.

Scanning of your badge by an Exhibiting company should always be done with your express consent.

By scanning your badge, the Exhibiting companies will collect your first name, family name, institution, location and e-mail address. This information should only be used by the Exhibiting companies for the purpose of evaluating attendance and to present their products and services directly to you by e-mail.

The ESTRO 2021 digital platform

Subject to the ESTRO 2021 Registration Policy, you will receive access to the ESTRO 2021 digital platform. These ESTRO 2021 digital platform will be made available to all ESTRO 2021 participants, speakers, ESTRO 2021 Media Partners, and Exhibiting companies and include:

- o the ESTRO 2021 Content repository
- o The ESTRO 2021 Mobile Application (ESTRO 2021 App).
- O The ESTRO 2021 Digital platform

The ESTRO 2021 digital platform is made available to you for networking, preparation and planning of the event, and follow-up purposes. The ESTRO 2021 digital platform allow you in particular to contact and exchange information with other ESTRO 2021 participants and exhibitors. By using the ESTRO 2021 Tools, you hereby agree to abide by Terms of Use of ESTRO 2021 digital platform. Wi-Fi

The average result from all rating per session and per speaker might then be published through the ESTRO 2021 reports.

Attendees

The event that you have registered for might be subject to export control, sanctions or other legal restrictions. ESTRO aims to comply with all laws and regulation applicable to it and therefore reserves the right to withhold acceptance of your registration based on restrictions arising from any EU sanctions regulations.
